






Total 2022 / 2023 Revenue \$15,766,129. *




low-risk auditee for the last sixteen years.



Families have opportunities for Parent Development, leadership and Advocacy Parenting Classes and Support groups. Our program offered Parenting classes and support groups at several locations. These included the Circle of Security and Fatherhood with PEACE Thriving not Just Surviving.

Some highlights of these groups include: Fatherhood with PEACE received a free narcan training and other community resources. Five of our Fatherhood participants received training to facilitate 24/7 Dad curriculum two of which are currently facilitators in training and will likely be officially co-facilitating groups this program year for other dads! The 24/7 Dad is a parenting curriculum especially designed for the male caregiver/parent. Fatherhood with PEACE provides a safe space for dads of young children to learn about themselves and the development of their children and form supportive relationships with other men in our community.










The Early Childhood Alliance facilitated several support groups for mom's called Thriving Not Just Surviving. This is the breakdown of which head start sites were represented in these meetings. Of the 14 moms and female caregivers that participated in these groups, three are now

co-facilitator because their leadership potential was recognized during the sessions.



Our Program

Health Staff:

Our program provides Chompers Dental Clinics in partnership with Syracuse Community Health Center. The program provides exams, cleaning and fluoride varnish. All children receive tooth-brushing kits throughout the school year. The program has resumed tooth brushing in classrooms fall of 2022 with a dry tooth-brushing model. Beginning fall of 2023 teachers may continue with the dry tooth-brushing model or resume back to regular tooth brushing with the children. The dental Clinics have expanded to include the more children in our collaboration with Catholic Charities. These clinics are through Syracuse Community Health Centers school based clinics.

We continue to collaborate with the Syracuse Lion's Club to provide vision screening to the children. They assist our program in screening the children within the first 45 days of enrollment. In the six years of our partnership, approximately 1200 children have been screened, with over 120 children needing glasses. They also cover the cost of lenses and frames for families without insurance; and will also replace a child's glasses if they are broken. When a child is fitted for glasses, and returns to school, the nurse rescreens the child with their glasses on, if the child still does not pass they are referred back to their eye doctor for another evaluation. The SPOT Vision screener is able to detect a potential problem with the child's prescription so it can be corrected.

Fall of 2019, we collaborated with The Gebbie Speech and Language Hearing Clinic through Syracuse University to perform hearing screening on children at our two largest Head Start sites. Dr. Kristin Kennedy, Licensed Audiologist from The Gebbie Speech and Language Clinic through Syracuse University, and her audiology students perform hearing screening at selected location each fall. The medical students screened 70 children this year between the two sites. Planning for fall of 2023 to add daycare collaboration children.

Our program worked with Central NY Regional Emergency Medical Services to create an AED program. Each center is now equipped with adult/child AED's. A Pediatrician on the Health Services Advisory Committee is our provider and oversees the AED program. Each center has many staff members who are trained in CPR/FA/AED and prepared to use the AED in an emergency. Our program is working with Belay- a food allergy training and preparedness program to provide allergy and anaphylaxis training to all Head Start staff. In addition, all PEACE, Inc. centers have emergency epinephrine stations with Auvi-Q auto-injectors. The Auvi-Q auto-injector comes in three different milligram doses based on weight. The program is equipped with all three doses of the epinephrine for use on children, each classroom has a chart that lists the children's weight. In the event of an anaphylactic reaction emergency, teachers look at the weight chart to find which dose to use. Each dose has a second auto-injector if needed. This training and stocking of non-patient specific epinephrine is in compliance of Elijah's Law. The emergency epinephrine stations are kept with the AED and Stop the Bleed kits in proximity to classrooms/lobbies of each PEACE Head Start center.

All Head Start nurses are trained in the National Stop the Bleed campaign. The purpose of the campaign is to build national resilience by better preparing the public to save lives by raising awareness of basic actions to stop life threatening bleeding following everyday emergencies and natural disasters. New this spring all staff that take CPR/FA/AED are now trained on Stop the Bleed, the American Red Cross has added Stop the Bleed into its training curriculum.

Our program has been transitioning back to our regular programming this year, while learning to live with the COVID-19 pandemic behind us. Our program created a COVID-19 Mitigation Policy in the spring of 2023, if in the event of an increase in COVID-19 we will refer to our policy. We continue to watch our local community levels and follow the NYSDOH and OCFS in order to make changes safely for children and staff.

Upcoming for fall of 2023 is a new partnership with the Onondaga County Lead Program for a mobile unit to come to the centers and collaborations to do lead testing. Parents must sign a permission form for their child to participate.

School Readiness

The Office of Head Start (OHS) defines school readiness as "children are ready for school, families are ready to support their children's learning, and schools are ready for children." Important ingredients of school readiness are the skills, behaviors, and knowledge that children need to acquire in developmental domains. These domains include social emotional; physical; language; cognitive; literacy and mathematics. OHS has outlined research-based birth to five years of age milestones for school readiness in their Head Start Early Learning Outcomes Framework (ELOF). We implement researched-based curricula that align with the ELOF in both our center-based and home-based models to enhance efforts in helping our children reach age-appropriate school readiness goals. Our program uses the child outcomes assessment tool, Teaching Strategies GOLD, to measure our children's progress toward reaching the ELOF milestones. The chart below reflects our Spring 2023 GOLD aggregate assessment of children's skills and knowledge in essential ELOF school readiness domains. These results indicate that the majority of children's skills and knowledge assessments were in the meeting or exceeding expectations ranges in all domains. The aggregate results also showed the percentages of children's skills falling in the meeting or exceeding expectations ranges increased in all domains from our Winter GOLD to our Spring GOLD assessment periods.

The Improving Head Start Readiness Act of 2007 requires the Office of Head Start (OHS) to implement ongoing monitoring of all programs receiving federal funds. Head Start recognizes that responsive caregiving builds on social, back-and-forth interactions with a child. These interactions support children's engagement, learning, and school readiness as well as support other positive outcomes that persist into adulthood. OHS uses the Classroom Assessment Scoring System® (CLASS), a valid and reliable researched-based observational tool, to assess grantees' classroom quality of interactions. Past reviews of this nature have been carried out in-person by a certified CLASS® observer. However, this year OHS piloted the use of Grant recipient video recordings to determine the viability of capturing grantee video observations as part of their monitoring process for CLASS® reviews. Our program's review was chosen to be part of this pilot. As such, we identified four in-house Head Start staff to be videographers. They were trained by OHS representatives about video technology requirements; how to capture quality video; and trained on video submission procedures. In total, twenty-nine of our program's pre-school classrooms were videotaped for the review process. Our Head Start Director and Child Development and Health Services Manager reviewed all of the videos for quality purposes before final submission to the OHS. The videos were then observed and scored by OHS contracted CLASS® certified observers. Subsequently, an OHS monitoring review report was provided to us showing program-level aggregate

CLASS® scores. These results have been used to guide program training and technical assistance to support our staff in preparing children for school readiness. As example, we offered pre-service workshops to education staff explaining the who, what, when, where, how and why OHS as well as, our program uses CLASS® in its monitoring process and how it relates to professional development and classroom quality.

Our Program

Nutrition

During our 2022-2023 PEACE INC EHS/HS program year, Nutrition Staff focused on implementing best practices, policies and procedures that meet the nutrition needs of all enrolled children, including special diets for each individual who requires a modified menu due to a food allergy, intolerance, medical condition, developmental or sensory challenge and cultural preference. Our PEACE EHS/HS special diet modification process has been recognized and videoed by NYS

Office of Child and Family Services (OCFS) for special diet management in a child daycare setting. All staff will continue to be trained through Belay on managing food allergies and intolerances.





Our Nutrition Coordinator, as a NYS Certified Dietitian Nutritionist continues to serve on the Syracuse University Falk College, Advisory Board and with the Academy of Nutrition and Dietetics as a preceptor to support dietetic interns in learning and demonstrating community nutrition dietetic competencies. This past year, SU interns developed for our program, nutrition related social media communication, activities

and videos to support our coordinators in outreach to our family participants. We continue to maintain an ongoing relationship with Syracuse University professors to share nutrition related projects and information that may impact food access and intake among individuals in our community target population.



Over this past year, we supported an Onondaga County Health Department Fellow in a nutrition education for pregnant and new moms on how to make baby food at **Health Department** home. We continue conversation and collaboration with ongov.net/health · facebook.com/ongovhealth the Onondaga County Health Department on community based nutrition initiatives and projects.

As we proceed, we will continue to provide recommended and approved Child and Adult Care Food Program (CACFP) menu of foods that support enrolled participants in their personal growth, development, and school readiness goals.

Program Activities

The "Same Book" Program:

This program is part of the Head Start/ Early Head Start Literacy Plan which is designed to implement an effective classroom and literacy program which, in turn, intentionally promotes and facilitates the growth and development of child and family literacy. The belief is that "Same Book" can also increase the reading experience in the community. Each year a book is chosen and sent home with each child in our program. The idea is to interconnect the "Same Book" concept at home and at school to increase and support family connections around literacy and reading.


Head Start/Early Head Start partnered with Liverpool High School Students to plan for the Same Book Distribution and family event. A committee of early childhood education professionals, the Liverpool High School Early Childhood Program, and Head Start parents met to create a guidebook of activities to go home with each family which contains developmentally appropriate recommendations and activities for families to use along with the book which establishes the importance of parents as child's first teacher.

This year we chose the book Ice Cream Face by Heidi Woodward Sheffield. The Early Childhood Education students at Liverpool High school created activities that support our school readiness goals. Together we planned and implemented this event, and children and their families got to experience the activities and even make homemade ice cream!

Families are encouraged to participate in "Same Book" activities in the classroom and center with their child. Children are also sent home with a corresponding Parent Guide.
